Teen's Promise

Every year thousands of new teen drivers like me get killed or badly injured in car crashes. I know you love me and want to protect me. You've made the following rules to keep me safe when I'm driving.

I have read each rule and initialed beside it to show I understand what it means and agree to obey it.

I will never:

- Drive without a sober, licensed co-pilot who has been approved by you, in the passenger seat beside me.
- Drive between the hours of _____ : _____ and _____ : _____ .
- Drive on these roads (Please define.)

- Drive after using illegal drugs.
- Drive after drinking any alcohol.
- Drive without my seatbelt fastened.
- Allow anyone to ride in my vehicle without a seatbelt.
- Talk on a cell phone or text while I am driving. If I need to make a call, I will pull over in a safe location first.
- Drive aggressively or show hostile behavior toward other drivers.
- Race or engage in stunts or other risky behavior.
- Conceal tickets, warnings or crashes from my parents.
- Allow anyone else to drive the car.
- Get in a car with a driver who is under the influence of drugs or alcohol.
- Wear headphones when I'm driving.
- Eat, drink or smoke while I'm driving.
- Allow anyone else to smoke in the car.

The consequences of failing to abide by these rules will be:

I will always:

- Obey all speed limits, traffic signs, and traffic lights.
- Do my best to tell you when I feel pressured to do things that make me uncomfortable or worry me.
- Let you know where I am going, whom I am with, when I will arrive and when I will return. If my plans change, I will let you know as soon as possible.
- Keep the music and noise at a level where I can still hear noises and sirens.
- Try to make a plan for how I will get home safely before I go out.

The consequences of failing to abide by these rules will be:

Parent/Guardian’s Promise to Teen

Because I love you, trust you, and want you to be safe:

I will always:

- Provide and maintain a safe vehicle for your driving practice.
- Pay (or co-pay) for your driving lessons and materials.
- Be available for driving practice for at least an average of _____ hours per week.
- Provide practice on a variety of road types and driving conditions.
- Share my observations and coaching in a calm and respectful manner.
- Wear my seatbelt and require everyone in my vehicle to wear his or hers.
- Avoid making decisions that will jeopardize my health and safety or cause you to lose your trust in me.
- Provide you with Safe Passage as defined below.

- Drive under the influence of alcohol or drugs
- Ride with a driver who has had too much to drink.
- Use my cell phone or text when I drive.

The consequences for failure to abide by these rules will be:

The Safe Passage Clause

If you are ever in a situation that threatens your safety and you contact me for a safe ride home, I promise to pick you up without question. It doesn't matter where you are, what time it is or what the situation is. I would rather drive across town at 3 a.m. to pick you up than identify your body in the morgue the next morning.

I will not yell at you or be angry because I want you to call me if you need help. We will postpone discussions about that situation until we can both discuss the issues in a calm, caring way.
